BACKGROUND & PROJECT DESCRIPTION

The NASA Advisory Council (NAC) was established in 1977 to provide consensus advice and recommendations to the NASA Administrator. The NAC's members are chosen by NASA and serve at the pleasure of the NASA Administrator. They meet several times a year for fact finding and deliberative sessions and is comprised of standing committees focusing on specific program areas. The NAC's committees and subcommittees are also supported by Executive Secretaries and staff assigned from the NASA program area relevant to each respective group and management and legal compliance oversight for all of NASA advisory committees is provided by the NASA Advisory Committee Management Officer.

The NASA Authorization Act of 2017 directs the National Academy of Public Administration (the Academy) to conduct a review "to assess the effectiveness of the NASA Advisory Council and to make recommendations to Congress" on any changes to:

- Functions of the Council;
- Appointment of members to the Council;
- Qualifications for members of the Council;
- Duration of terms of office for members of the Council;
- Frequency of meetings of the Council;
- Structure of leadership and Committees of the Council; and
- Levels of professional staffing for the Council.

In conducting this review, the Academy will consider (1) the impacts of broadening the Council's role to include providing consultation and advice to Congress under section 20113(g) of title 51, United States Code and (2) past activities of the Council and the activities of other analogous Federal advisory bodies.

This study will be conducted over the course of approximately seven months. The final report to Congress and NASA will (1) present key findings from the research conducted, (2) assess the effectiveness of the NAC, and (3) provide recommendations for any needed changes in such areas as the NAC's structure and function, membership, meeting frequency, and staffing. This review will be led by a Panel of five Academy Fellows with support from a highly qualified professional study team.
